In February 2016, The Insurance Community University introduced their certification program for construction. The CCIP certification is a cutting edge approach to insurance education delivered through live, interactive webinars taught by TRUE experts in the field.

Working with the construction industry is only getting more challenging as forms change, construction contracts become even more important for the insurance transaction, case law changing that affect insurance interpretation and new building codes and requirements becoming effective.

# WHAT IS A "DESIGNATION" IN CONSTRUCTION?

- A Certification in Construction Insurance (CCIP) is awarded to individuals who have completed eleven (11) courses specifically designed for construction risk and insurance.
- The Certification course study teaches how to:
  - Identify risk exposures
  - **Understand** construction contracts
  - Understand the risk transfer process
  - **Design** an appropriate insurance program

## HOW IS THE DESIGNATION OBTAINED?

- The courses are taught online in a live webinar format.
- During the webinars all participants will be required to answer polling questions specific to the course materials and participate in discussions.
- There is a 10 question multiple choice test administered after each class.
- All eleven (11) courses are being taught in 2025. However, you do not have to complete all courses during 2025. You must, however complete all classes within a 2 year period. Classes do not need to be taken in order.

## WHO SHOULD ATTEND THE CCIP CLASSES?

- ALL insurance producers selling to construction clients
- ALL support staff working on construction risks
- New producers or support staff who want to work with construction clients

### DO THE CLASSES QUALIFY FOR CE?

- The classes will qualify for CE in many states including California and Washington.
- You do NOT have to sign up for the Certification to attend the classes.
- Individuals can sign up for any or all of the classes without seeking the certification.

### HOW DO YOU SIGN UP?

- You will sign up for each of the classes at www.insurancecommunityuniversity.com
- When you sign up, you will check the box that you want to obtain the CCIP Certification.
- Once you have successfully completed all (11) classes, you will receive your CCIP Designation.

#### HOW MUCH DOES THE DESIGNATION COST?

- The CCIP is NOT included as part of the Insurance Community University package pricing.
- For University Members the cost is \$50.00/Class
- For non-members each class costs \$85.00

## IS THERE A RE-CERTIFICATION REQUIREMENT?

- **YES.** There is an annual re-certification requirement for each designation.
- You can re-take any of the classes in the designation to qualify for recertification.
- You can also take any other classes offered by ICU, other than Ethics, to qualify.
- Some designations have specific update classes you can attend, as well.

## DESIGNATION EXAM REQUIREMENTS

- In order to earn the designation, participants must attend the designation class LIVE on the scheduled date AND meet all the qualifications during the class including attending the entire class, completing all the polling questions, and pass the exam within 48 hours following the class.
- **Exams** are sent out to participants immediately following the class.
- Participants have 48 hours to take the exam and submit. There will be two attempts allowed.
